







- 5. Trademark image\* (File format EPS/JPEG/TIF, resolution 300 dpi)
- **6. Certification of membership** (e.g., Department of International Trade Promotion, Thai Chamber of Commerce, or trade associations)
- 7. Copy of halal product certification\* (for those wishing to participate in the Halal Food Zone)
- 8. Copy of organic product certification\* (for those wishing to participate in the FutureFood Zone
